Dear San Diego Charter School Leader:

As you may know, last November local voters authorized the San Diego Unified School District to issue \$2.8 billion in school facilities bonds. Within this \$2.8 billion pool, the district has preliminarily set-aside \$350 million for charter school projects and established a 7-member Charter School Facility Committee

to advise the district on how to allocate these funds. The members of the committee, our charge and mission, meeting agendas, and other information are accessible on the district web site (insert link). We welcome you to attend our meetings and we conduct them in compliance with the Brown Act open meetings laws.

One of the first items on the Committee's work plan is an initial survey to help the Committee to assess the general needs of current charter schools. Toward this end, we have developed and posted a simple, online survey that we ask you to complete. The purpose of the survey is simply to begin to assess potential district-wide charter school facilities needs in San Diego.
